This area is static and will not move on the home screen while you scroll through the options below.

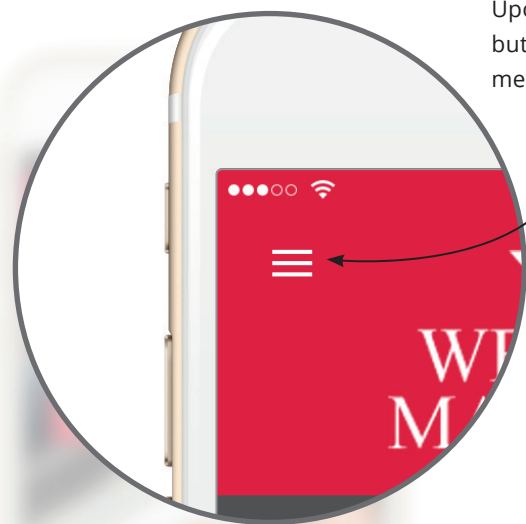
This scroll arrow indicates that more content is below.

Upon pressing the hamburger menu button from the home screen, the menu slides out from the left.

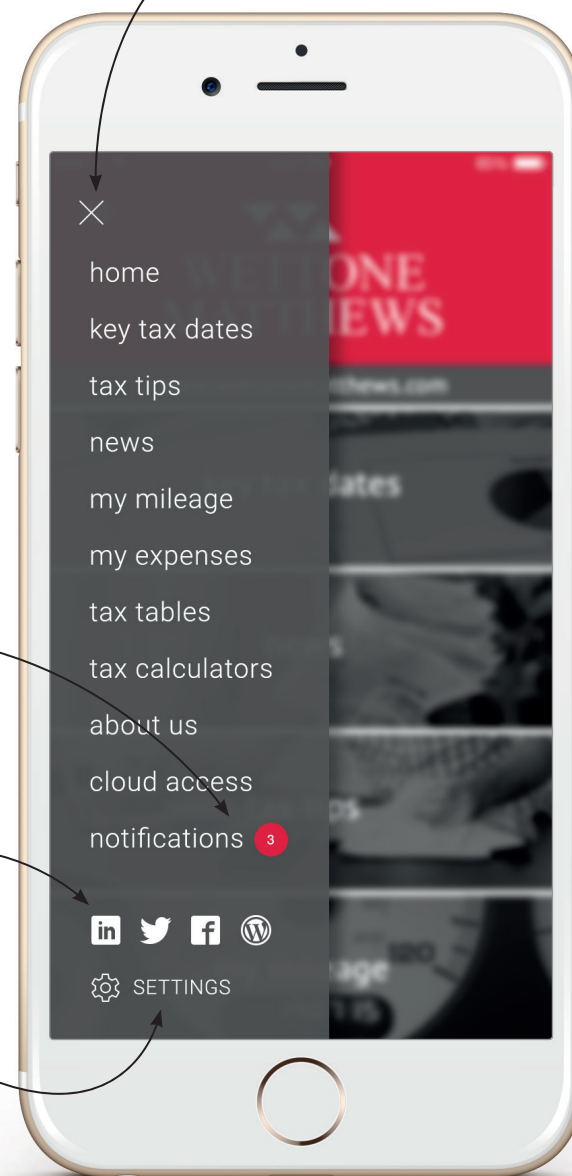
Push notifications will turn into messages to ensure your clients are always updated, even if they have their notifications disabled.

Settings for the app. Here, you can control the order of the blocks on the home screen.

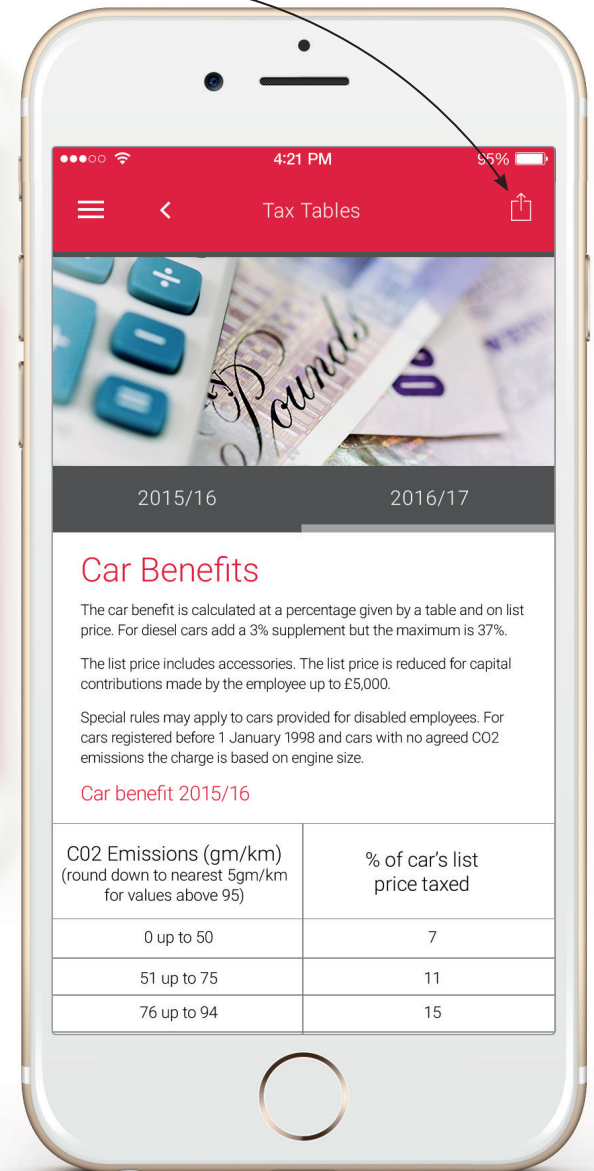
This will close the menu slide bar and take you back to your content.
